 - Promote the inclusion of circular economy principles in the continuous improvement of our processes, encouraging the recovery of our customers' used equipment and the development of products designed under eco-friendly criteria.
 - Protect biodiversity and natural resources, because our equipment (networks, devices...) use critical materials and limited resources that must be handled in an exemplary manner
 - Promote the energy and environmental transition, from the point of view of telecommunications as a source of innovation capable of offering sustainable solutions
 - Encourage the procurement of energy-efficient products and services
 - Promote good environmental and energy use practices among employees
4. Compliance with current legislation related to energy efficiency, the use and consumption of energy, environmental legislation and those other commitments signed by MASORANGE.
5. The implementation of this policy through communication, training and awareness of employees, to ensure the development of their work with the utmost respect for the environment from a life cycle perspective.
6. The promotion of communication and collaboration with public administrations, business associations, consumer and user organizations, as well as other interested parties, which help us to maintain satisfactory collaborative relationships.
